GULF COAST DISCOUNT MEDICAL PLAN is committed to protecting your privacy. This Statement of Privacy applies to the GULF COAST DISCOUNT MEDICAL PLAN Web site and governs data collection and usage at all GULF COAST DISCOUNT MEDICAL PLAN sites and services; it does not apply to other online or offline sites, products or services. Collection of your Personal Information

Use of your Personal Information
